
Objective of Anti-Ragging Committee:

Key Roles and Responsibilities of Anti-Ragging Committee:

- **Policy and Oversight:** Ensure compliance with UGC Anti-Ragging Regulations and regularly update institutional anti-ragging policies.
- **Awareness and Prevention:** Plan and implement awareness programs, orientation sessions, and display informative materials on the consequences of ragging.
- **Affidavit Compliance:** Ensure all students and parents submit the prescribed anti-ragging affidavits.
- **Monitoring and Vigilance:** Conduct active surveillance in hostels, campus areas, and coordinate with the Anti-Ragging Squad for immediate action on incidents.
- **Periodic Review:** Hold regular meetings, especially at the start of each academic session, to review preventive measures.
- **Complaint Handling:** Receive complaints from students, parents, or staff, and conduct fair, impartial, and time-bound inquiries into incidents.
- **Disciplinary Action and Reporting:** Recommend disciplinary measures against offenders and maintain communication with authorities including the District Administration, Police, and UGC.
- **Record Keeping:** Maintain documentation of meetings, complaints, actions taken, and preserve affidavits and awareness records for compliance and audit purposes.
